## Certificates of Compliance

### Reduction of Toxics in Packaging

**\*CONEG CERTIFICATION/MODEL TOXICS IN PACKAGING COMPLIANCE**

**\*CALIFORNIA TOXICS IN PACKAGING PREVENTION ACT (AB 455, AB 2021, SB 774)**

Western Pulp Products Company certifies that the molded fiber packaging components it manufactures and supplies comply in all respects with CONEG's Model Toxics Packaging law and California's Toxics in Packaging Prevention Act. Specifically,

- 1) We certify that the regulated metals – lead, mercury, cadmium, and hexavalent chromium – are **not intentionally added** to any package or packaging component during the manufacturing process.
- 2) We further certify that the **sum of the incidental concentration levels** of lead, mercury, cadmium and hexavalent chromium present in any package or package component does not exceed 100 parts per million by weight.
- 3) We will maintain adequate documentation of this certification for inspection upon request.

**EUROPEAN UNION'S DIRECTIVE ON PACKAGING AND PACKAGING WASTE (94/62/EC OF 20 DECEMBER 1994, AS AMENDED BY 2004/12/EC) AND THE CEN PACKAGING STANDARDS (2005/C 44/13)** pertaining to heavy metals content requirements - Western Pulp Products Company certifies that the molded fiber packaging components manufactured and supplied comply in all respects to the package requirements for heavy metals of the European Parliament and Council Directive 94/62/EC on packaging and packaging waste; namely, the sum concentration levels of lead, mercury, cadmium and hexavalent chromium present in packaging or packaging components do not exceed 100 parts per million by weight. Additionally, any molded fiber packaging component manufactured and supplied that is part of a finished packaged product also meets the **Essential Requirements on the Composition and the Reusable and Recoverable, Including Recyclable, Nature of Packaging in Annex II of Directive 94/62/EC.**
